

NOTICE OF POTENTIAL DATA EVENT

Paylogix, LLC (“Paylogix”) is providing notice an event that may involve information related to certain individuals. While Paylogix is unaware of any identity theft or fraud in relation to this event, Paylogix is taking steps to provide appropriate notifications. This notice includes information about what happened, the steps taken since learning of the event, and the resources related to individuals to better protect against potential misuse of their personal information, should they feel it appropriate to do so.

What Happened? Paylogix recently experienced a network disruption involving certain computer systems and services. In response, Paylogix promptly took steps to contain the disruption and restore impacted systems to secure, full functionality. Paylogix also initiated a thorough investigation to determine the nature and scope of the event. Through the investigation, Paylogix determined that certain systems were subject to unauthorized access and certain files were copied from the Paylogix network between November 13, 2025 and November 18, 2025 as part of a cyber event. As a result, Paylogix is currently undertaking a comprehensive review of the potentially involved files to determine what information is present and to whom it relates. This review is ongoing.

What Information Was Involved? While the review to determine what exact data was potentially affected is ongoing, the information is expected to vary by individuals and may contain data such as name, address, policy number, and email. In some instances, it may also contain Social Security numbers.

What We Are Doing. We take this event seriously, and the confidentiality, privacy, and security of information in our care are among our highest priorities. We moved quickly to investigate this event, assess the security of our systems, and understand the information involved. Additionally, we notified federal and local law enforcement and are cooperating with their investigation. We also recognize the evolving nature of cybersecurity and, as part of our ongoing commitment to information security, we are reviewing our existing security policies and will continue to implement appropriate cybersecurity measures in the future.

What You Can Do. We encourage individuals who may be affected to remain vigilant against incidents of identity theft and fraud by reviewing account statements and monitoring free credit reports for suspicious activity and to detect errors. Additionally, we encourage individuals to check their explanations of benefits regularly to ensure that there has not been any unexpected activity. Under U.S. law, a consumer is entitled to one free credit report annually from each of the three (3) major credit reporting bureaus, Equifax, Experian, and TransUnion. Consumers may also directly contact the three (3) major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a one (1) year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven (7) years. Should consumers wish to place a fraud alert, please contact any of the three (3) major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two (2) to five (5) years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General. The Federal Trade Commission also encourages those who discover that their information has been misused to file a complaint with them. Consumers can obtain further information on how to file such a complaint by way of the contact information listed above. Consumers have the right to file a police report if they ever experience identity theft or fraud. Please note that in order to file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement, the Federal Trade Commission, and the relevant state Attorney General. This notice has not been delayed by law enforcement.

For New Mexico residents, consumers have rights pursuant to the Fair Credit Reporting Act, such as the right to be told if information in their credit file has been used against them, the right to know what is in their credit file, the right to ask for their credit score, and the right to dispute incomplete or inaccurate information. Further, pursuant to the Fair Credit Reporting Act, the consumer reporting bureaus must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to consumers' files is limited; consumers must give consent for credit reports to be provided to employers; consumers may limit "prescreened" offers of credit and insurance based on information in their credit report; and consumers may seek damages from violators. Consumers may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active-duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
